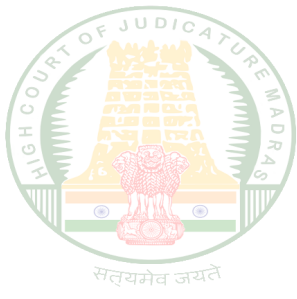

3.Private notice to the fifth respondent is also permitted.

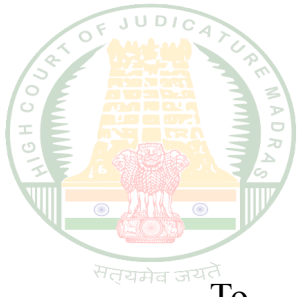
