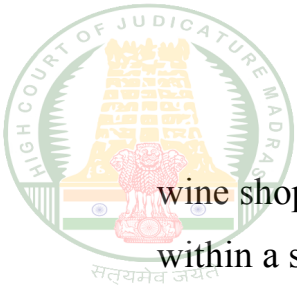

(Order of the Court was made by D.BHARATHA CHAKRAVARTHY, J.)

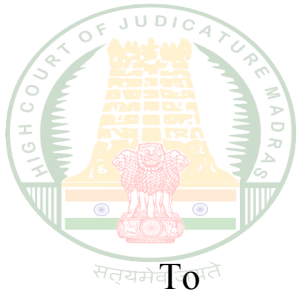
