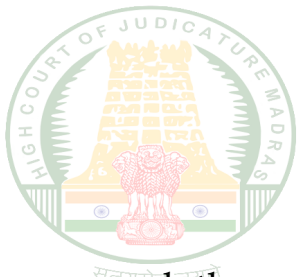

Prayer in WMP(MD). 14290/ 2024 :

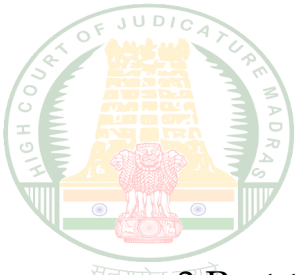
