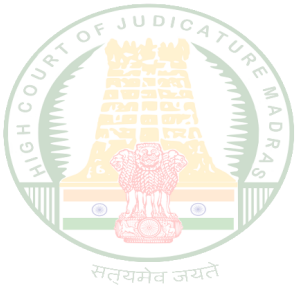

2. Mrs.K.Porkodi, learned counsel for the Government, takes notice for the first respondent and Mr.B.Ramanathan, learned counsel, takes notice for the second respondent.

From the perusal of the proceedings dated 17.02.2026, it is evident that the first respondent, while permitting the petitioner to retire from service with effect from 30.04.2024, permitted her to draw provisional pension.
