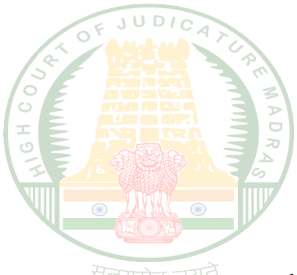

ORDER

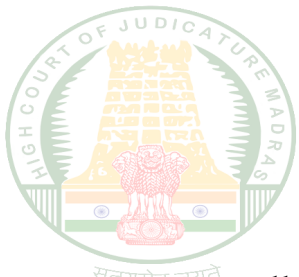
The above petition has been filed seeking orders to condone the delay of 543 days in filing the appeal, challenging the award dated 19.07.2023 passed in M.C.O.P.No.352 of 2020 on the file of the Motor Accident Claims Tribunal / Additional District Court, Karur.

2. Despite receipt of notice, the first respondent has not turned up.

3. Heard the learned counsel appearing for the petitioner and the learned counsel appearing for the second respondent.

4. The learned counsel appearing for the petitioner would submit that the petitioner has not deposited the entire amount so far.

5. Considering the above and taking note of the fact that the impugned order came to be passed on 19.07.2023, this Court is of the view that the petitioner should be directed to deposit the entire award amount before the Tribunal within a stipulated time. Hence, this petition will be allowed on depositing the entire award amount together with interest and costs to the credit of M.C.O.P.No.352 of 2020 on the file of the Motor Accident Claims Tribunal / Additional District Court, Karur, on or before 22.09.2025, failing which, this petition shall stand dismissed
