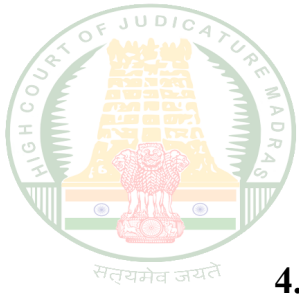
**ORDER**

3.Accordingly, this petition is ordered.

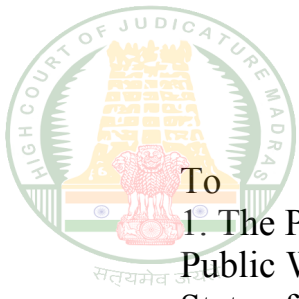
