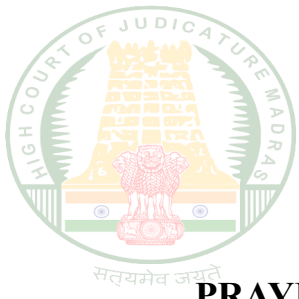

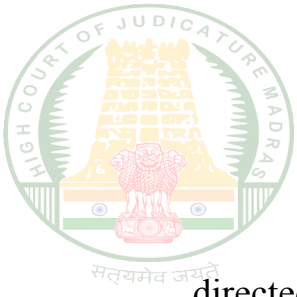

### **ORDER**

Mr. R. Ramasamy, learned Government Advocate, takes notice on behalf of the first respondent and seeks time to secure instructions and file a counter affidavit.

2.Issue notice to respondents 2 to 7, returnable in three weeks. Private notice is also permitted.

3.Mr. B. Karunanithi, learned counsel for the petitioner, submitted that in W.P.(MD) No.7558 of 2026, this Court, vide order dated 18.03.2026, had

directed the first respondent to conduct an enquiry with regard to the acceptance of Form No.VII filed by the petitioner. It was further observed that, insofar as the validity of the Annual General Body Meeting or the removal of the earlier office bearers or the conduct of a fresh election is concerned, it is for the parties to approach the competent Civil Court. Despite the said observation, the first respondent has gone into the validity of the removal of the earlier office bearers.

4.Post the matter after three weeks. There shall be an order of interim stay till the next date of hearing.
