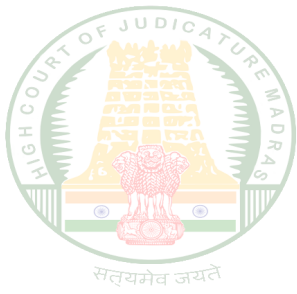

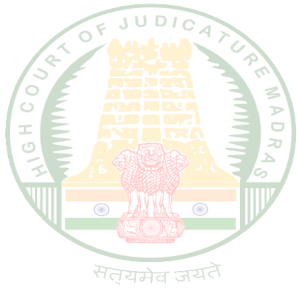
ORDER

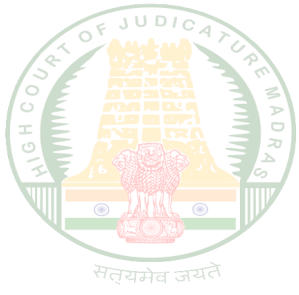
