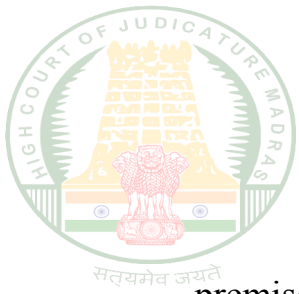

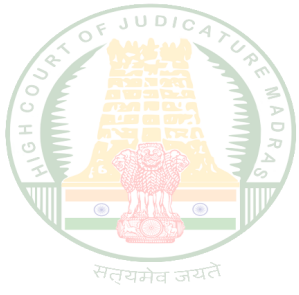
premise that directions have been issued to seal the petitioner's workshop, namely, Star Welding Workshop.

4.Post the matter along with W.P.(MD) No.5129 of 2026.

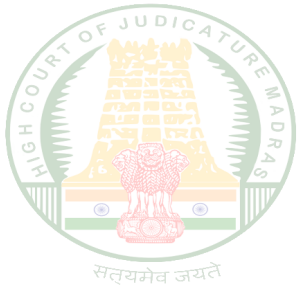
