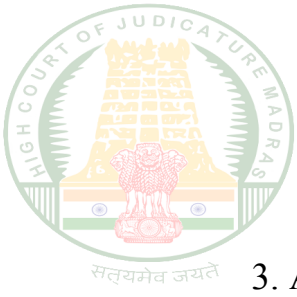

2. Perusal of the averments made in the supporting affidavit clearly indicates that the petitioner wants to prevent the trustees from exercising their rights in the Trust's property. Such disputes cannot be decided in the writ petition. Hence, we do not find any merits in this writ petition.
