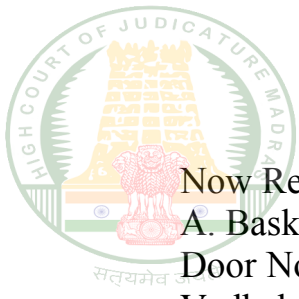

### **ORDER**

Heard the learned Counsel for the petitioners.

2.Registry has raised a maintainability with regard to the representation of the second respondent / plaintiff Trust by one A.Baskar Pandiyan.

3.The learned Counsel for the petitioners / appellants has represented stating that since one A.Baskar Pandiyan is presently representing the second respondent / plaintiff Trust and he is also independently a party to the



proceedings, the cause title is proper and there is no necessity for taking out an application for accepting the cause title.

4. In considering the arguments of the learned Counsel for the petitioners / appellants and also going through the objection of the Registry, I find that in the Trial Court, the second respondent / plaintiff Trust was represented by one A.Kumar Pandiyan, who is now admittedly dead and now the appellants claim that the Trust is represented by an other plaintiff A.Baskar Pandiyan. Admittedly, the Trust was represented by Kumar Pandiyan, who is now dead, before the Trial Court as well as the First Appellate Court. Now, in the present Second Appeal, a formal application to accept the cause title has to be necessarily filed and I do not find any infirmity in the objection raised by the Registry. The appellant is ordered to take out a formal application for accepting the cause title.

5. The Registry is directed to number the petition to accept the cause title, if it is otherwise in order and list the same for hearing on **23.06.2026**.
