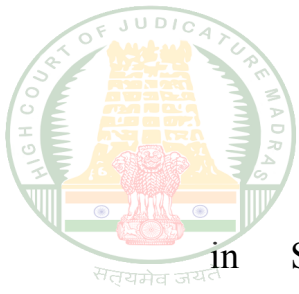

The petitioner, with a grievance that the 4th respondent, with the support of the 3rd respondent, who is working as a Tahsildar, coerced him to sell his property to him, lodged a complaint and also filed this writ petition seeking a writ of mandamus to take departmental action as against the 3rd respondent to illegally support the 4th respondent.
