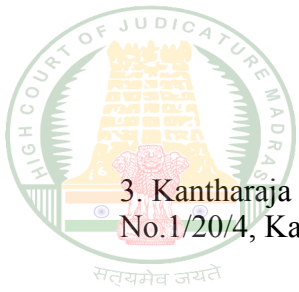

After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

COMMON AWARD

CMA(MD)No.1480 of 2024 is filed by the Insurance Company. C.MA(MD)No.1726 of 2024 is filed by the claimants. Today, the parties have amicably settled fixing of total compensation award amount for a sum of Rs.58,30,000/-. Further, the Tribunal has awarded a sum of Rs.27,52,932/-. The Insurance Company already deposited a sum of Rs.44,27,677/-. Further, the balance amount of Rs.14,02,323/- shall be deposited within a period of four weeks from today. The mother of the deceased Manikandan is entitled to 70% of the award amount and the sister of the deceased is entitled to 30% of the award amount, together with proportionate interest accrued on deposit made by the Insurance Company.

In view of the above, C.M.A.(MD)No.1480 of 2024 is dismissed and CMA(MD)No.1726 of 2024 is allowed.
