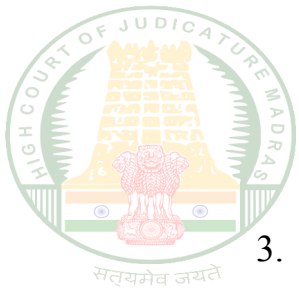

PRAYER: Second Appeal filed under Section 100 of the Civil Procedure Code, to set aside the judgment and decree, dated 08.12.2005 made in A.S.No.86 of 2003 on the file of the II Additional Subordinate Judge, Tiruchirappalli, confirming the judgment and decree, dated 23.10.2003 made in O.S.No.2145 of 1993 on the file of the II Additional District Munsif Court, Tiruchirappalli.

JUDGMENT

This matter is listed today under the caption for extension of time.

2. It is seen from the records that this Court vide order, dated 29.10.2024, directed the learned First appellate Judge to dispose of the appeal on merits in accordance with law within a period of three months. The learned II Additional Subordinate Judge, Tiruchirappalli, has submitted a requisition seeking extension of time and this Court vide order, dated 19.08.2025 granted three months further time. Subsequently, the learned Subordinate Judge submitted a requisition, dated 06.01.2026, stating that the documents were found missing and proceedings for re-construction had already been initiated and seeks three months further time.
