This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant K.Sudalaiyandi and the counsel for the respondent/s Mr.N.Shyllappakalyan are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Both parties agreed for settlement by enhancement of compensation of Rs.50,000/- (Rupees Fifty Thousand only). The Insurance Company is directed to deposit the said amount, over and above already deposited, within a period of four (4) weeks positively. On deposit, the claimant is at liberty to withdraw the above said amount and also the amount already deposited by the second respondent / Insurance Company before the Tribunal under intimation to the Tribunal. No costs.
