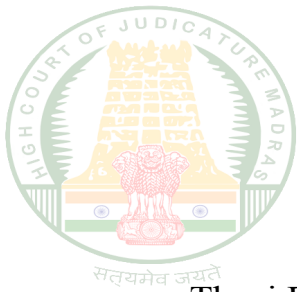

The matter has been listed today under the caption "for extension of time for trial Court".

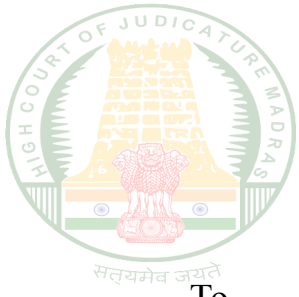
