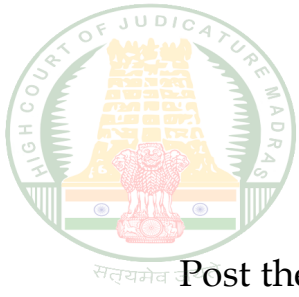
Prayer in CMP(MD). 14455/ 2024 :

Writ Petition, filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Mandamus directing the respondents to consider the petitioner for appointment to the posts of Group-II A Posts under Ex-Serviceman Category in pursuant to the Memo issued by the 3rd respondent vide Kurippanai No. 271/PSD-A2/2022 dated 07.05.2024 taking into consideration of the petitioner's ITI qualification as per G.O.Ms.No. 242, Higher Education Department dated 18.12.2012 and also taking into consideration of the petitioners Indian Army Special Certificate of Education or the corresponding certificate and allow him to participate in the further process and issue appointment order as per the order of selection of the petitioner within a stipulated time.
