**ORDER**

Thiru.N.Manoharan filed W.P.(MD)No.297 of 2021 seeking inclusion of his name in the revenue record in respect of the petition-mentioned properties(two items). The review applicant Thiru.N.Sathyaseelan who is the brother was shown as the fourth respondent. He did not enter appearance in the writ proceedings. The writ petition was allowed by me vide order dated 03.08.2022. Seeking review of the same, this application has been filed.

2. During the intervening period, two developments had taken place. The order of this Court was complied with and joint patta has been issued.

3. Secondly, Thiru.Sathyaseelan has filed partition suit in O.S.No.434 of 2025 before the II Additional District and Sessions Judge, Thiruchirapalli. I, therefore, do not want to keep this review application pending. I make it clear that I have not gone into the merits of the matter. The civil Court will decide the issue on merits based on the evidence adduced before the civil Court. I make it clear



that neither the compliance of the order dated 03.08.2022 in W.P(MD)No.297 of 2021 nor the issuance of joint patta will prejudice the case of Thiru.Sathyaseelan in the civil proceedings. This review application stands disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
