ORDER

[Order of the Court was made by DR.G.JAYACHANDRAN, J.]

Learned counsel appearing for the appellants submits that while the Government Order in G.O.(Ms) No.2010, Transport Department, dated 03.11.1987, does not make any difference between the working group and the administrative group among the employees of the appellant – Transport Corporation in respect of voluntary retirement compensation, the subsequent Government Order in G.O.Ms.No.75, Transport (C.1) Department, dated 19.09.2006, has specifically distinguished that the technical / administrative supervisors will be entitled to receive the other benefits viz., HRA, CCA, Health Allowance, Attendance benefits etc., as applicable to the Working Group, but, not voluntary retirement compensation. While so, the learned Single Judge has extended the benefit of voluntary retirement compensation, which is exclusively for Working Group to the respondent / writ petitioner and allowed the writ petition. Hence, the order of the learned Single Judges needs to be quashed.
