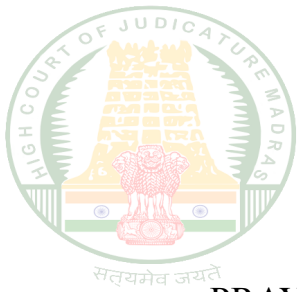

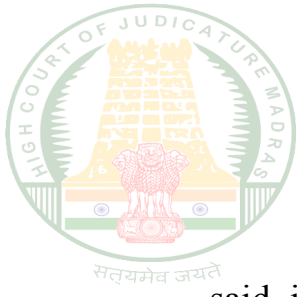

The prayer in this Review Petition is seeking to review the order passed in W.A.(MD)No.1404 of 2023, dated 01.09.2023.

2. The learned Single Judge, in the Writ Petition, in fact remitted the matter to the authority to refix the pay. On appeal, the Co-ordinate Division Bench of this Court dismissed the Writ Appeal. The

said judgment is now sought to be reviewed. In the meanwhile, the authorities have passed orders rejecting the request of the respondent herein to fix the pay, by order dated 24.09.2024, which has also been made the subject matter of challenge in W.P. (MD) No. 23815 of 2024.

3. In view of the above, this review application has become purely academic and nothing survives for consideration. Hence, no purpose would be served in hearing the Review Petition. Therefore, the condone delay petition is dismissed. Consequently, the Review Petition in Rev.Aplw(MD)SR.No.69350 of 2024 is also dismissed at the SR stage itself. There shall be no order as to costs.
