ORDER

The present Writ Petition has been filed seeking a direction to the first respondent to issue a joint patta by including the names of the legal heirs of the petitioner's great-grandfather, namely, Mayandi Thevar, in respect of the property comprised in Old Survey No.99/4 and T.S.No.9/31A1A, situated at A. Senkulam, Thirumangalam Taluk, Madurai District, based on the petitioner's application dated 25.07.2025.

2. The contention of the petitioner is that the petitioner's great-grandfather was the owner of the property and had several legal heirs. However, the respondents have issued patta solely in favour of the 3rd respondent. Therefore, the petitioner seeks issuance of a joint patta by including the names of all the legal heirs.

Therefore, the 2nd respondent/Tahsildar is directed to issue notice to the petitioner, the 3rd respondent, and all other legal heirs, and thereafter conduct an enquiry and pass appropriate orders in accordance with law. The said exercise shall be completed within a period of four (4) months from the date of receipt of a copy of this order.

4. With the above direction, the writ petition stands disposed of. No costs.
