Issue notice to the respondent returnable in eight weeks. Private notice is also permitted.

2.The learned counsel for the petitioner states that the respondent is working

as a Assistant Professor in an engineering college and that she has suppressed this factum in her application. The Court below has ordered Rs.20,000/- per month as monthly maintenance. The petitioner is said to be earning more than Rs.1 Lakh rupees. The amount awarded by the Court below cannot said to be excessive. If the respondent is gainfully employed anywhere, the impugned order may require modification.

3.The petitioner states that he would pay a sum of Rs.10,000/- as monthly maintenance. This undertaking given by the petitioner is recorded. The petitioner shall deposit a sum of Rs.10,000/- to the credit of H.M.O.P.No.128 of 2022 on the file of the Sub Court, Sattur on or before 05.12.2024. He shall continue to do so every month till the disposal of the civil revision petition. This is of course subject to any vacate stay petition to be filed by the respondent and the final outcome of this civil revision petition.

4.There shall be an order of interim stay.
