Issue fresh notice to the fourth respondent returnable by four weeks. Private Notice is also permitted.

2. Batta in 3 days, failing which, the appeal shall stand dismissed automatically against the fourth respondent without any further reference to Court. Once batta is paid, Registry to issue process on the same day.

3. Affidavit of proof of service ought to be filed well in advance.

4. The learned counsel for the appellant would submit that the order of this Court dated 25.07.2024 has been complied with.

5. Registry is directed to verify whether the earlier order has been complied with. If complied, Registry is directed to call for the records from the concerned Court and if not, the appeal itself shall stand dismissed automatically without any further reference to Court.
