Prayer in WMP(MD). 21684/ 2024 :

To issue INTERIM DIRECTION directing the Respondents No.1 to 3 not to issue the patta infavour of any third person pertaining to the properties in S.No. 6/3 to the extent of 0.14.5 hectares and S.No. 10/4 to the extent of 0.17.0 hectares situated at Podasapatti Village, Madurai East Taluk, Madurai District to the extent of 78 Cents pending disposal of the above Writ Petition.
