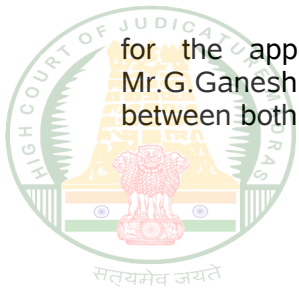

Both parties agreed for settlement of Rs.33,00,000/- (Rupees Thirty Three Lakhs Only) in full quit. The Insurance Company is directed to deposit the said amount, less the amount already deposited, within a period of four (4) weeks positively. On such deposit, the claimants / respondents 1 to 3 (respondents 2 and 3 who were shown as minors have already been declared as majors vide order dated 12.03.2026 made in C.M.P(MD)Nos.3323,3325,3326 and 3327 of 26) are entitled to withdraw the said amount in equal apportionment directly from the Bank under intimation to the Tribunal. No costs. Consequently, connected miscellaneous petition is closed.
