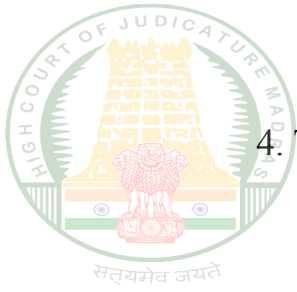

ORDER

2. This Court is of the view that there is no case made out for further reviewing the Order already passed. The order that was passed on 31.10.2025 was only in the light of requests made by the Counsels who appeared on that day for ordering additional remuneration to be paid to the Hon'ble Mr.Justice Mr.V.Bharathidasan, Retired Judge of Madras High Court in the light of the report that was filed pursuant to the Order dated 07.08.2025.
