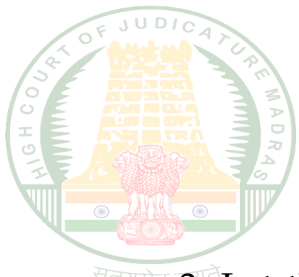
Prayer in CMP(MD). 16055/ 2023 :

To Stay all further proceedings pursuant to the impugned order made in E.P.No.95 of 2019 in O.S No.339 of 2010 dated 19.10.2023 on the file of the Sub Court, Tuticorin, pending disposal of the above Civil revision petition and thus render justice.

ORDER : This Civil Revision Petition coming up for orders on this day, upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Mr.J.ASHOK, Additional Government Pleader on behalf of the Petitioners, the court made the following order:-

The learned Additional Government Pleader would submit that the conditional order dated 04.12.2023 is complied by the petitioners by depositing 50% of the amount claimed in the execution petition. He has also produced a copy of the E-Challan for such deposit.

2. He would further submit that they filed appeal before the District Court, Thoothukudi. It is pending in I.A.No.3 of 2023 for condoning the delay in preferring the appeal. Now notice was served to the petitioner herein stating that it is posted on 22.02.2024.
