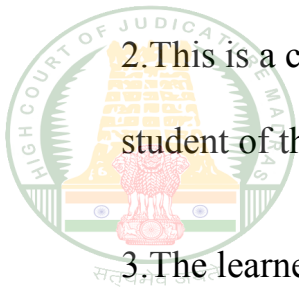
Prayer:

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, directing the Respondents 1 to 4 to consider the representation dated 01/09/25 and to initiate necessary action against the Respondents 5 and 6 in accordance with the provisions of Tamilnadu Recognized Private Schools (Regulation) Act, 2018, The Right of Children to Free and Compulsory Education Act, 2009 and The Tamil Nadu Town and Country Planning Act, 1971 r/w. respective rules framed therein for the illegal transfer of school property situated in T.S.No.101, Thirunagar, Dindigul East Taluk, Dindigul District for the purpose of construction of marriage halls namely M.S.P.Auditorium and M.S.P.Annexe and to pass such further or other orders as this Honble Court may deem fit and proper in the said circumstances of this case and thus render justice.

2.This is a case putting up a construction in the open land, which has been utilized by the student of the fifth respondent school.

3.The learned counsel appearing for the fifth respondent submits that the construction has been put up on a distinct portion of the land owned by the Society and it has been nothing to do with the School or School property.

4.To clarify the said contention, records pertaining to the purchase of the land, declaration of assets of the School, declaration of assets of Society, planning permission for the building and other relevant documents shall be produced before this Court on the next date of hearing.

5.Post the matter on 11.02.2026.
