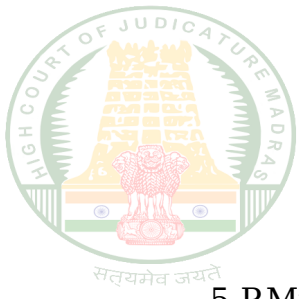

This Writ Petition has been filed seeking to direct the respondents 3 & 4 to pass appropriate order to permit the



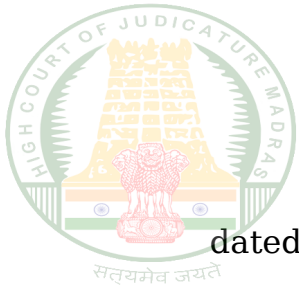
