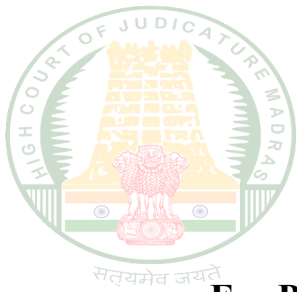

To Set aside the order dated 14.10.2025 passed by this Honourable Court in CMP(MD).No. 16284 of 2023 in CMA(MD)SR. No. 83769 of 2023 on the file of this Court for non-filing of Batta within the requisite time and Restore the same on the file this Court and thus render justice.

ORDER

(Order of the Court was made by the Hon'ble N.Anand Venkatesh J.)

This petition has been filed to set aside the order dated 14.10.2025 passed by this Court by dismissing the appeal on the ground that batta was not filed within the requisite time.

2. Notice has been served on the first respondent and the first respondent is represented through the counsel. Insofar as the second respondent is concerned, the second respondent remained exparte even before the Tribunal. Hence, we deem it fit to dispense with notice insofar as the second respondent is concerned.

3. The learned counsel appearing for the petitioners submitted that the Insurance Company has approached this Court questioning the quantum of compensation granted by the Tribunal.
