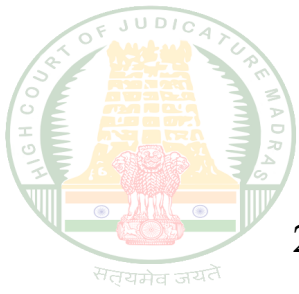

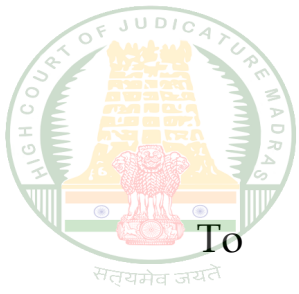
2.Since the petitioner is a third party and seeks action as against a Government Servant, this Court is not inclined to entertain this writ petition and his remedy lies elsewhere.

3.However, the learned Special Government Pleader appearing for the official respondents, based on the instructions, submits that already an enquiry was conducted and they have found that the 17th respondent has obtained the job by using a fake certificate and therefore, necessary action has also been taken as against the 17th respondent.
