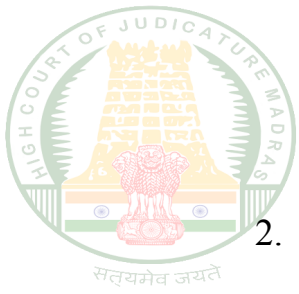

PRAYER: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of MANDAMUS or any other appropriate writ or direction to the respondents 2 to 4 to cancel the Patta granted in the name of the 7th respondent under Patta No. 4675, for the property under Old Survey No. 262/3, Re-Survey Nos. 285/1, 285/5, 285/6, Panikanendal Village, Mangulam Group, Manamadurai Taluk, Sivagangai District and to issue the Patta in the name of the Petitioner pursuant to the orders passed in W. P. (MD). No. 23725/2025, dated 04.11.2025 and consequentially forbear the 7th respondent from taking possession of the property of the petitioner under Old S. No. 262/3, Re-Survey Nos. 285/1, 285/5, 285/6, Panikanendal Village, Mangulam Group, Manamadurai Taluk, Sivagangai District.

ORDER

The petitioner seeks a direction for the cancellation of the patta No.4675 in favour of the 7th respondent and for the issuance of patta to the petitioner pursuant to an order dated 04.11.2025 in W.P(MD)No.23725 of 2025.



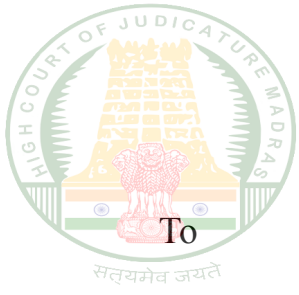
2. Learned counsel for the petitioner submits that the cancellation of assignment was set aside by the earlier order dated 04.11.2025 of this Court. In those circumstances, he submits that the 7th respondent is endeavouring to dispossess the petitioner with the assistance of the police. Considering these aspects, until the next date of hearing, there shall be an order of interim injunction restraining the respondents from interfering with the petitioner's possession of the property.

3. Learned Special Government Pleader accepts notice for respondents 1 to 6 and learned Government Advocate(crl.side) accepts notice for the 8th respondent. Issue notice to the 7th respondent returnable on 09.01.2026. Private notice is also permitted.
