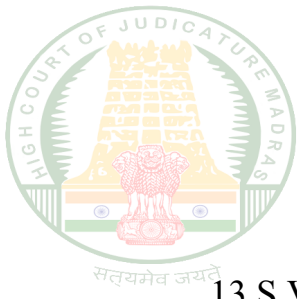

2.Mr.P.Saravana Pandian, learned counsel appears for the fourth respondent.

3.It is seen from the records that service awaited for the respondents 1 to 3 and 5. Despite service of notice to the respondents 7 to 9 and 12 and their names have also been printed in the cause list, when

the matter is taken up for hearing today, there is no representation on behalf of the respondents 7 to 9 and 12 and the notice sent to the respondents 13, 6, 10, 11 and 14 were returned with an endorsement 'unclaimed' and 'no such person in the address' respectively. Therefore, this Court thought it fit to appoint a Legal Aid Counsel for the respondents 13, 6, 10, 11 and 14.

Accordingly, this Court appoints Ms.R.Devadharshini, (Enrol.No.5025/2024, Mobile No.70108 17931) as Legal Aid Counsel for the respondents 7 to 9 and 12 and also appoints Ms.S.Amutha Bharathi, (Enrol.No.4110/2023, Mobile No.98433 90485) as Legal Aid Counsel for the respondents 6, 10, 11, 13 and 14 to assist the Court. The High Court Legal Services Committee attached to this Bench shall bear the expenses for the conduct of the case, as per guidelines.

5. The learned counsel for the petitioner is directed to serve copies of the papers to the Legal Aid Counsel for the respective respondents.
