The petitioner also seeks interim stay against the operation of the above impugned orders.

ORDER

This petitioner was appointed as a Village Administrative Officer at Kadamangalam Village on 29.09.2025 and he has joined duty on 01.10.2025. While so, the Revenue Divisional Officer, Paramakudi Division, Ramanathapuram has passed an order in Na.Ka.No.A5/219/2025, dated 24.11.2025, transferring the petitioner to Mandalamanickam as Additional Village Administrative Officer. Challenging the same, the petitioner has filed this writ petition.

2.The learned counsel appearing for the petitioner submits that the petitioner has been transferred to Mandalamanickam as Additional Village Administrative Officer within one month from the date of his joining duty. 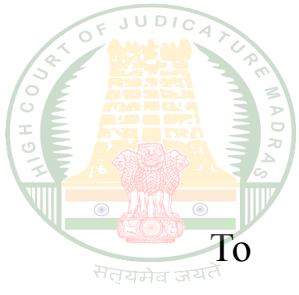
3.Since the petitioner has made out a *prima facie* case, there shall be an order of interim stay for a period of four weeks.
