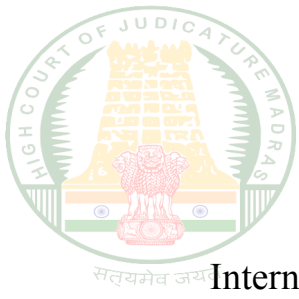
ORDER

2.According to the learned counsel appearing for the writ petitioner, it has been brought to the notice of the writ petitioner that a settlement deed has been executed in favour of the Trichy Corporation and therefore, they may be granted liberty to challenge the same by way of an independent proceedings.
