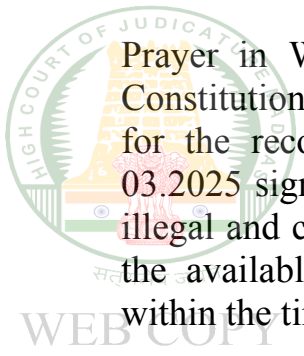

Prayer in WP(MD)No.35724 of 2025: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the records pertaining to the impugned Notification No. 18/MRB/2025, dated 03.12.2025 on the file of the Respondent No.3 and quash the same as illegal to the extent of filling up through direct recruitment the available vacant post of Audiometrician in Tirunelveli Medical College Hospital and consequently to direct the Respondents No.1 and 2 to consider the Petitioner for posting in the available vacant post of Audiometrician in Tirunelveli Medical College Hospital within the time stipulated by this Court.

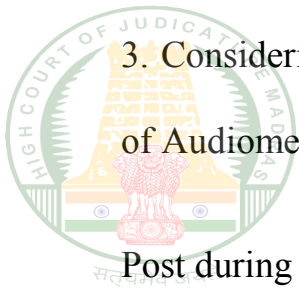


Prayer in WP(MD)No.16996 of 2025: Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorari and Mandamus for the records pertaining to the impugned order Na.Ka.No.19596/Ni.3/2021 dated 03.03.2025 signed on 02.03.2025 on the file of the Respondent No.2 and quash the same as illegal and consequently to direct the Respondent to consider the petitioner for posting in the available vacant post of Audiometrician in Tirunelveli Medical College Hospital within the time stipulated by this Court.

COMMON ORDER

The petitioner is working as a Female Nursing Assistant in Tirunelveli Medical College Hospital. She had undergone training in audiometrician for the post Audiometrician at Stanley Medical College Hospital in the year 2015 and 2016 and she was posted on deputation as Audiometrician at Tirunelveli Medical College Hospital. While so one Tamilarasi was transferred and posted in the place of Audiometrician at Tirunelveli Medical College Hospital. Therefore, the petitioner has filed a writ petition in WP(MD)No.20621 of 2021 challenging the order of transfer and disturbing this petitioner, who was working as Audiometrician. Pending the writ petition, the said Tamilarasi was transferred from there and thus, the post of Audiometrician at Tirunelveli Medical College Hospital became vacant. Therefore, this court by order dated 11.09.2024 in WP(MD)No. 20621 of 2021 directed the respondents to consider the case of the petitioner for posting her in the place of Audiometrician in Tirunelveli Medical College Hospital. A proposal was made to the Director of Medical Education.

2.While so there was a circular placed on the notice board inviting applications for filling up the posts of Audiometrician from the in-service candidates and this circular was issued pursuant to the permission of the Director of Medical Education. Without completing this process, the medical recruitment board has now called for applications to fill up the posts of Audiometrician by the impugned notification.



3. Considering the above submissions, the respondents are directed not to fill up the post of Audiometrician at Tirunelveli Medical College Hospital pending this writ petition.
