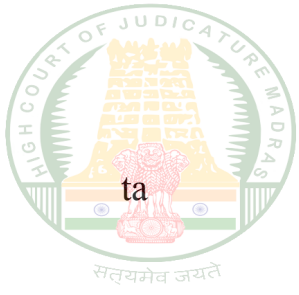
It is brought to the notice of this Court that connected writ appeals are pending before this Court in W.A.(MD)Nos.3069 to 3072 of 2025 etc..
