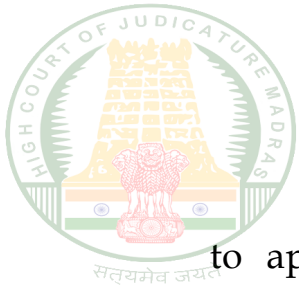

ORDER

2.The learned counsel for the third respondent submitted that the Petitioner has been implicated in a criminal case in Cr.No. 18/2022, which has been culminated into filing of charge sheet in C.C.No.976 of 2025, on the file of learned Judicial Magistrate No.I, Trichy.

In case, if any such application is filed, the same shall be disposed of within a period of four weeks from the date of receipt of a copy of this order.
