Considering the facts and circumstances of the case, this Court is inclined to grant an interim stay till the disposal of the Civil Miscellaneous Appeal in C.M.A.(MD)No.223 of 2026, subject to a condition. Accordingly, an order of interim stay is granted on condition that the petitioner shall deposit 50% of the award amount, along with proportionate accrued interest and costs, to the credit of M.C.O.P.No.184
