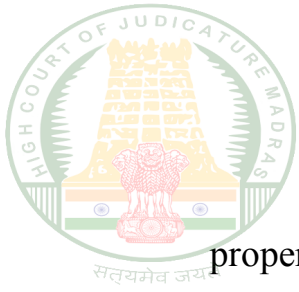

This petition has been filed to vacate the interim stay granted by this Court on 13.11.2025 in CMP(MD) No. 18390 of 2025 in CRP(MD) No. 3367 of 2025.

2. Heard both sides and perused the materials available on record.

3. Mr. N. Dhilip Kumar, learned counsel appearing for the petitioner, submitted that the suit has been filed for declaration and mandatory injunction to remove the electric poles. However, the revision has been filed by a third party who is not connected with the removal of the electric poles.

4. Since the revision has been filed only by a third party for the
