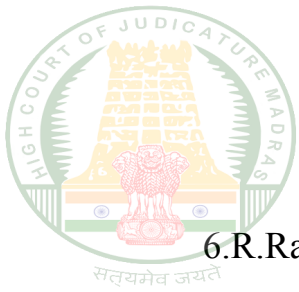

2. In view of the above, the respondents are directed to maintain *status quo* as on date till the next date of hearing.

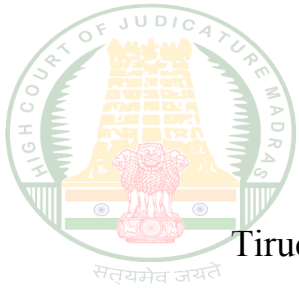
