State on 18.05.2023, (iv) by initiating process to fill up approximately 600 (plus) posts of Lecturer by way of placement/promotion, (v) by filling up 261 posts of Principal (School) by way of placement in various Government Senior Secondary Schools of the State and initiating process for filling up 300 vacancies of Headmasters by way of promotion and lastly initiating the process by the State Government for cancellation of deputation in respect of 51 Lecturers (School New) in various subjects facilitating their postings in the Schools.
