“Pursuant to orders dated 21.06.2025, Learned State Counsel prays for four weeks' further time to have Instructions as to whether the case of the petitioners was covered by the judgment passed in CWP No. 6192

of 2020, titled as ***Ramesh Chand Versus State of Himachal Pradesh and others***, decided on 02.12.2024.

2. At this stage, Learned Vice Counsel appearing for petitioner in CWP No. 7898 of 2019, Mor Dass versus State of Himachal Pradesh and others, points out that petitioner-Mor Dass has died and she intends to bring on record the Legal Heirs as the right to sue accrues to them and the outcome of the instant writ petition, may have an effect on them. Accordingly, as prayed, let appropriate steps be taken for bringing on record, the Legal Heirs, within four weeks.

List the matter on **22.08.2025.**"

2. So far as the CWPOA No. 7898 of 2019, Mor Dass versus State of Himachal Pradesh and others is concerned, Learned Counsel for the petitioner prays for four weeks' further time to bring on record the legal representatives/heirs of deceased Mor Dass and/or to have instructions for continuing with the present petition or not. Prayer appears to be genuine.

3. Let needful be done within four weeks positively by way of last opportunity, failing which, CWPOA No. 7898 of 2019, shall abate qua the petitioner therein.

4. Likewise, Learned State Counsel prays for and is granted further time to have instructions.
