CWPIIL No. 55 of 2026.**

These three cases are required to be taken up together since the issue is common.

In CWP No.3246 of 2026, prayers made by the petitioner are for permission to raise the level of the protection wall and also for removal of the silt from the Reservoir bed of Kol Dam Hydroelectric Project, so that Hotel Hot Springs can be safeguarded.

In CWPIIL No. 55 of 2026, issues have been raised regarding technical inspection of the Kol Dam Reservoir area,

Tattapani, for removal of excessive silt accumulation, to increase the height of the protection wall etc. and to construct a separate building for Government Primary School, Tattapani, which apparently gets submerged during the monsoon.

In CWPIIL No. 30 of 2026, the issue is regarding construction of the illegal encroachment on the NTPC acquired land by Prem Lal Raina, who is running the Hotel Hot Springs there.

Accordingly, let pleadings be completed in the cases by the next date of hearing.

To come up on **19.06.2026**, the date already fixed in CWPIIL No.55 of 2026.

Exparte order dated 05.05.2026 in CWP No. 3246 of 2026 is recalled, keeping in view the above issues.

CMP No. 12903 of 2026 in CWPIIL No. 30 of 2026

The present application is disposed of by taking on record the latest photographs of the encroached dam area at Village Tattapani.
