Respondents have not filed compliance report/affidavit in terms of order passed on previous date, indicating compliance of order/direction issued by the Court, against which no stay has been granted by any Competent Court.

These execution petitions were filed in May 2025, i.e. about 6 months ago, therefore, we have no other option except to take coercive action for implementation of the order/directions by the Court.

For persuasive request made by learned Additional Advocate General, two weeks' further time is granted to ensure compliance of order/directions passed by the Court, which is in force, failing which the respondents may be committed to civil imprisonment, for which Chief Secretary to Government of Himachal Pradesh, is directed to arrange the subsistence allowance required to be deposited for continuing the civil imprisonment of the defaulter.

This appeal has been preferred by the State against judgment dated 22.11.2025 passed in CWP No.155 of 2024 (*Kashmir Singh Rawal & Ors. vs. State of Himachal Pradesh and others*), whereby relying upon judgment of Division Bench of this Court dated 12.11.2024 passed in LPA No.338 of 2024 (*Narayan Dutt Sharma vs. State of Himachal Pradesh and others*), learned Single Judge has allowed the prayer of the petitioners therein in terms of judgment passed in Narayan Dutt Sharma's case (*supra*).

Therefore, this appeal is to be adjudicated separately. Accordingly, Registry is directed to de-tag this LPA from these execution petitions.

Thereafter, notice be issued to respondents in this appeal, returnable on **18.03.2025**, on taking steps by appellant-State within one week.
