05/ 08.05.2026: This Cr.M.P. has been filed for modification and extension of time of order dated 07.07.2025 passed in A.B.A. No.8160 of 2024 and order dated 12.09.2025 in Cr.M.P. No.2513 of 2025.

2. Learned counsel for the petitioner prays for modification of condition of bailor. He submits that petitioner does not have any relative in the State of Jharkhand and neither he has any property in the State of Jharkhand, thus, the bail condition may be modified.

3. Learned counsel for the petitioner by referring to the supplementary affidavit stated that Prasenjit Mandal, S/o Purna Ch. Mandal, resident of Sahebganj Road, Ward No.12, Bhangni 1<sup>st</sup> Khanda, Dinhata-1, Koch Bihar, West Bengal- 736135 (Brother-in-law of the petitioner) and Soumen Roy, S/o Swapan Roy, R/o 27/1, Beni Master Lane, Kolkata, VTC- Sarsuna, P.O. Sarsouna, District South 24 Pargana, West Bengal- 700061 (one of the staff of the N.G.O. of the petitioner) want to stand as bailors.

4. Considering the said submissions, order dated 07.07.2025 passed in A.B.A. No.8160 of 2024 and order dated 12.09.2025 in Cr.M.P.

No.2513 of 2025 is modified to the extent that Prasenjit Mandal, S/o Purna Ch. Mandal, resident of Sahebganj Road, Ward No.12, Bhangni 1<sup>st</sup> Khanda, Dinhata-1, Koch Bihar, West Bengal- 736135 (Brother-in-law of the petitioner) and Soumen Roy, S/o Swapan Roy, R/o 27/1, Beni Master Lane, Kolkata, VTC- Sarsuna, P.O. Sarsouna, District South 24 Pargana, West Bengal- 700061 (one of the staff of the N.G.O. of the petitioner) will stand as bailors of the petitioner. The aforesaid two bailors will file an affidavit before the Trial Court to the effect that as and when required the bailors will produce the petitioner before the Trial Court.

5. Further, since the petitioner is resident of Behala Police Station, Kolkata, West Bengal and he has got no connection with the State of Jharkhand, he is directed to appear before the Officer-in-Charge, Behala Police Station, District Kolkata, once in every month.

6. The Trial Court will not insist for landed property of the bailors.

7. The orders dated 07.07.2025 and 12.09.2025 are modified to the aforesaid extent only.

8. Accordingly, the Cr.M.P. stands disposed of.
