1. This I.A., seeking condonation of delay of 64 days in instituting the appeal is allowed, since sufficient cause has been shown therein.

2. This I.A. is disposed of.

3. Learned counsel for the appellant states that within ten days from today, the appellant will deposit in this Court the entire awarded amount along with interest.

4. This statement is accepted as an undertaking to this Court and therefore, will have to be complied with by the appellant.

5. Relying on the above statement, proceedings for execution of the impugned judgment and award dated 23.11.2024 passed by the learned Presiding Officer, Motor Vehicles Accident Claims Tribunal, Ranchi in Motor Accident Claim Case No. 52 of 2020 initiated vide Execution Case No. Misc. MACT 58 of 2025, are stayed, until the next date.

6. This I.A. is, accordingly, disposed of.
