It appears that after conviction and order of sentence passed in S.T. No. 74 of 2016, the appellant were granted provisional bail till 15th February, 2019 for preferring the appeal but the the provisional bail was not confirmed within time accordingly, under order dated 25.04.2019 the appellants were directed to surrender before the court below and to file surrender certificate thereafter under order dated 17.05.2019 as the appellants have not surrendered, hence, the trial court was directed to take all coercive measures against the appellants for their apprehension.

Supplementary affidavit has been filed on behalf of the appellants stating therein that the appellants were on provisional bail till 15.02.2019. Thereafter, appellant no. 3 namely, Umesh Sao has been arrested as per order of the Hon'ble Court and sent him in judicial custody since, 29.05.2019. The appellant no. 2 namely, Ranjeet Sao and appellant no. 4 namely, Lakhan Sao have been voluntarily surrendered in the court below on 03.06.2019 and sent to them in Judicial custody. The appellant no. 1 namely, Ruplal Sao has voluntarily surrendered on 14.06.2019.

I.A. No. 1270 of 2019 has been filed on behalf of the appellants praying for grant of bail after suspending the sentence during the pendency of the appeal, who have preferred this criminal appeal against the judgment of conviction dated 16.01.2019 and order of sentence dated 16.01.2019 passed by Sri. Sanjay Kumar

Singh, Addl. Sessions Judge-XII, Hazaribag in S.T. No. 74 of 2016.

This appeal will be heard.

During pendency of this criminal appeal, above named appellants are directed to be released on bail on furnishing bail bond of Rs. 25,000/- (Rupees twenty five thousand)each, with two sureties of the like amount each to the satisfaction of the court of learned Addl. Sessions Judge-XII, Hazaribag in connection with S.T. No. 74 of 2016,. Further, the appellants are directed to deposit cost of Rs. 1,000/-each in the account of **Bandi Kalyan Kosh, Birsa Munda, Birsa Munda Central Jail, Hotwar, Ranchi being A/C No. 490710210000007, Bank of India, Branch-Booty More, Customer Id-103610460, IFSC Code No. BKID0004907** and furnish a receipt of aforesaid deposition of amount before the trial court on the date of their furnishing bail bond.
