1. The present civil miscellaneous petition has been filed for modification of the order dated 28.01.2026, passed in W.P. (C) No.103 of 2026.

2. It has been submitted by the learned counsel for the petitioner that since typing has been done wrongly in the cause title of the writ petition regarding the addresses of respondent Nos.3 & 4, the same has been reflected in the order dated 28.01.2026, passed in W.P.(C) No.103 of 2026 and as such prayer has been made to rectify the same.

It has further been submitted that the correct addresses of respondent Nos.3 & 4 are as follows :-

Further, in paragraph No.7 of the order dated 28.01.2026, “Deputy Commissioner, Hazaribagh”, has wrongly been mentioned in place of “Deputy Commissioner, Giridih”. Accordingly, prayer has been made for modification of the same.

3. In view of above submission of learned counsel for the petitioner, the order dated 28.01.2026 is modified to the extent that the respondent Nos.3 & 4 shall be read as “Deputy Commissioner, Collectorate Campus (New Barganda), P.O – Giridih, P.S. - Giridih Sadar, Dist.- Giridih – 825301, Jharkhand” & “Circle Officer, Jamua, Circle Officer, Jamua, Office of Circle Officer, P.S & P.O – Jamua, Dist – Giridih – 825318”. Further, in paragraph No.7, in place of “Deputy Commissioner, Hazaribagh”, it shall be read as “Deputy Commissioner, Giridih”.

4. Accordingly, the present civil miscellaneous petition is, hereby, allowed and disposed of.

5. Let the certified copy of this order always be issued along with the order dated 28.01.2026.

6. So far as I.A. No.5713 of 2026 is concerned, since there is no cause of action arise for intervening in the present petition, as it is merely correction of the clerical error, I find no reason to entertain the instant interlocutory application.

7. Accordingly, I.A. No.5713 of 2026 is, hereby, rejected.
