**02/ 17.03.2026:** The relief sought by the petitioners in this writ petition has already been clarified by this Court vide order dated 18.02.2026 passed in W.P.(S) No.1091 of 2026.

2. In the aforesaid case, on the assurance of the learned Advocate General and also the other respondents, it was held that the experience Clause 5(i),(ii)&(iii) of the Advertisement No.12 of 2025 is not an essential condition for appointment.

3. In view of the above fact, I think that the case of the petitioners is covered by the aforesaid order.

4. Further, the petitioner has already been allowed to appear in the examination.

5. Thus, in fact the grievance of the petitioners can be said to have been redressed.
